Image for Linux is a console based application (not web-based).

Creation of bootable media for drive backup does not by default turn on assistive technologies such as a screen reader as it is a limited version of the desired OS. The Linux version provides guidance on enabling Speakup.

For assistive technology users such as screen reader users, we recommend the TeraByte Drive Image Backup and Restore Suite V3.41 or newer – Windows GUI Version. Image for Linux V3.41 – CUI Version offers an accessible experience for people with mobility, hearing and cognitive challenges.
